#### A. Items Opening Meeting

- 1. Call to Order Mayor Eric Love called the meeting to order at 6:31 PM.
- 2. Pledge Mayor Eric Love led the Pledge of Allegiance.
- 3. Invocation Mayor Eric Love
- 4. Roll Call Village Secretary called roll: Present were: Mayor Eric Love, Mayor ProTem Justin Hamilton, Councilmember Shelly Molina, Councilmember Tex Tubbs, Councilmember Mark Maund. Absent: Councilmember Cliff McInnis. A guorum was present.

#### **B.** Public Comments

Resident welcomed Jim Gresham to Village staff, addressed Mayor's recent announcement of resignation and expressed hope the Village Council and POA Board will work together for the benefit of our community.

Resident inquired if the Village Council was able to override ACC ruling to allow addition of roof top deck to single family dwelling. The resident was informed staff would be able to respond to this inquiry.

#### C. Mayor Report

Mayor Eric Love update to his possible resignation with expected sale of Point Venture residence. No current prospects for sale of home at this time, Mayor will not present resignation and until further notice is and will remain Mayor. Mayor apologized for any confusion.

Mayor Eric Love reminder of upcoming POA Board of Directors election and PVPOA meet the candidates' event on May 3 at 6:30pm in the Venture Room.

#### D. Travis County Sheriff's Report

Deputy Nick McCaughey said there were no issues reported. Deputy McCaughey responded to inquiry regarding underage golf cart drivers and assured that any reckless, unsafe driving of golf carts is not tolerated.

Greg Johnson, Travis County Fires/ESD Dist 1, had nothing to report at this meeting.

#### E. Items to Consider

Mayor ProTem Justin Hamilton made a motion to approve minutes for March 15, 2023 as presented. Councilmember Tex Tubbs seconded the motion. All present approved. Motion carried.

Mayor Eric Love announced reorder of agenda items, Item E. 2 and Item E. 3 will be moved to Item G. Executive Session to seek legal advice pursuant to Section 551.071 of the Texas Government Code.

4. Discuss and possible approval of ILA with Travis County Fire/ESD Dist 1 for emergency management and code enforcement. Councilmember Tex Tubbs presented a motion to discuss this item. Councilmember Shelly Molina seconded the motion to discuss. Councilmember Tex Tubbs requested consideration of review of code enforcement coordination at 3 years in lieu of 5 years stated in ILA. Mayor ProTem Justin Hamilton responded he had no hesitation approving the 5-year term agreement as presented.

Mayor ProTem Justin Hamilton made a motion to approve ILA with Travis County Fire/ESD Dist 1 for emergency management and code enforcement as presented. Councilmember Mark Maund seconded the motion. All present approved. Motion carried.

- 5. Discuss and schedule Council workshop for building and zoning ordinance amends and updates. Councilmember Shelly Molina request the Council schedule a workshop to review building and zoning code for possible updates and amendments. Mayor ProTem Justin Hamilton agreed a workshop could be helpful for Council discussion. Wednesday, May 10 at 6:30pm chosen as possible date and time for Council workshop.
- 6. Discussion only regarding Village awareness of short-term rental properties renting by the hour. Council has been made aware of short-term rental property in Point Venture with option of hourly rental of property. Council will discuss short term rental policies and regulations at later date when further data has been presented for Council consideration.
- 7. Discuss and possible approval for Village issued Security State Bank MasterCard in the name of Jim Gresham with \$1,000 credit limit. Mayor ProTem Justin Hamilton presented a motion to discuss this item. Councilmember Mark Maund seconded the motion to discuss. Councilmember Shelly Molina discussed that the Village has a tight budget and purchase of unnecessary items possible with open \$1,000 credit available. Councilmember Tex Tubbs concern that \$1,000 limit reconciled monthly is an annual \$12,000 of loose spending. Mayor ProTem Justin Hamilton felt \$1,000 limit was not overly excessive.

Mayor ProTem Justin Hamilton made a motion to approve Village issued Security State Bank MasterCard in the name of Jim Gresham with \$1,000 credit limit. Councilmember Mark Maund seconded the motion. Councilmember Shelly Molina approved. Councilmember Tex Tubbs opposed. Motion carried.

CapMetro has released information for FY 2023 Build Central Texas allocation for Village of Point Venture of \$101,982 carryover allocation is \$73.464, bringing total BCT allocation funds to \$175,446. These funds are made available to assist with street resurfacing and improvements.

Councilmember Tex Tubbs requested Council consider future structure and appointment of Village Treasurer to be non-staff to insure separation of duties within Village accounting responsibilities, a volunteer from within our community and a CPA or finance background.

#### 2. Building Department

March Building Report

Councilmember Shelly Molina gave March building report. There were no permits issued for single family dwelling. There were permits issued for outdoor storage shed, foundation repair, swim/spa install and driveway extension. There were no certificates of occupancy issued in March.

Jim Gresham reported there were three dogs that got loose, all pets were quickly reunited with their owners. There were four downed deer. Coyote have been sighted in Point Venture.

Clearing Services Agreement for backhoe use to help clear and organize Community Collection Center after 1<sup>st</sup> and 3<sup>rd</sup> Saturday collection dates has been fully signed and executed by the PVPOA and the Village of Point Venture.

Councilmember Tex Tubbs reported that bid process for all Village roadway crack seal project will be rebid. Travis County Transportation is still not able to provide ILA road repair services due to shortage in available personnel.

#### A. Items Opening Meeting

- 4. Roll Call Village Secretary called roll: Present were: Mayor Eric Love, Councilmember Shelly Molina, Councilmember Tex Tubbs, Councilmember Mark Maund., Councilmember Cliff McInnis. Absent: Mayor ProTem Justin Hamilton. A quorum was present.

#### **B.** Public Comments

Resident addressed Mayor Love regarding child reported missing in Point Venture on Monday, May 8. He read texts received from Mayor Love and expressed his displeasure in the responses and reaction to Village employee to access the Flock Safety cameras to assist in any way to locate missing child. Resident expressed his desire that Mayor Love quickly sell his home and resign as Mayor.

Resident addressed Council expressing his desire that manning the guard house at entrance be reinstituted. Having guard house at entrance manned could be helpful and a deterrent for situations such as Monday and the missing child reported.

Resident addressed Council to request the Council revisit requiring a prohibition of roof top decks. Noise nuisance complaints are currently often received and roof top decks create additional noise nuisance.

Employee of the Village addressed Mayor Eric Love regarding Mayors delay in returning call Monday, May 8 about the missing child report; further employee level dissatisfaction expressed regarding numerous employee disagreement items which were heatedly discussed between employee and Mayor Love. Employee abruptly departed meeting; Mayor Eric Love announced he quit and left the meeting.

#### C. Council Workshop

Discuss amendments and updates to Village Building Code and Zoning Ordinance. Councilmember Shelly Molina chaired the workshop and began with review of zoning ordinance. Interpretation of density; are accessory dwelling unit height restrictions unreasonable; zoning use summary horse stables permitted for SF district realistic for Point Venture; numerous items discussed for consideration at future meetings and/or workshops.

Councilmember Shelly Molina brought workshop discussion to a close, building ordinance revisions will be discussed at a future meeting.

#### Jan 2022 – April 2023 P&Z actions include:

- Reviewed MF-1 (townhouse) project site plans for 5 townhouse development projects involved multiple reviews (up to 3 per project)
